**RULES FOR THE TRANSFER TO THE BORDER AUTHORITIES OF
THE FEDERAL SECURITY SERVICE OF DATA ON THE LOCATION
OF VESSELS REPEATEDLY CROSSING THE STATE BORDER OF THE
RUSSIAN FEDERATION AT SEA WITHOUT PASSING BORDER,
CUSTOMS (IN PART OF PERFORMING CUSTOMS OPERATIONS
RELATED TO THE ARRIVAL (DEPARTURE) OF VESSELS)
AND OTHER TYPES OF CONTROL**

1. These Rules establish the procedure for transferring to the border authorities of the Federal Security Service (hereinafter referred to as border authorities) data on the location of vessels that repeatedly cross the state border of the Russian Federation at sea without undergoing border, customs (in terms of customs operations related to the arrival (departure) of vessels) and other types of control (hereinafter referred to as vessels).

2. Data on the location of vessels shall be transferred to border authorities by:

the Russian center for the vessel identification and long-range tracking system (hereinafter referred to as the Russian center for the identification system), established in accordance with clause 1 of RF Government Resolution No. 922 of 8 December 2008 "On measures to implement the vessel identification and long-range tracking system", in electronic form using the Internet information and telecommunications network - for vessels specified in clause 1 of Article 9.1 of the Law of the Russian Federation "On the State Border of the Russian Federation", with the exception of fishing vessels on which technical means for monitoring the vessel's location are mandatory;

centers of the industry system for monitoring aquatic biological resources, observation and control of the activities of fishing vessels (hereinafter referred to as Russian monitoring centers), created in accordance with the Decree of the Government of the Russian Federation of February 26, 1999 No. 226 "On the creation of an industry system for monitoring aquatic biological resources, observation and control of the activities of fishing vessels" - for fishing vessels on which technical means for monitoring the location of the vessel are installed on a mandatory basis.

To obtain information about vessels intending to repeatedly cross the state border of the Russian Federation, the Russian center of the identification system and Russian monitoring centers (hereinafter referred to as centers) use data from the centralized accounting of state port control, which is carried out by captains of sea ports in accordance with paragraph 1 of Article 79 of the Merchant Shipping Code of the Russian Federation.

3. The following data on the vessel's location shall be transmitted to border authorities:

- a) the name of the vessel, its call sign and the identification number of the International Maritime Organization (if any);
- b) the maritime mobile service identifier MMSI (if any);
- c) the state under whose flag the vessel is navigating;
- d) the geographic coordinates of the vessel location;
- d) the date and universal coordinated time (UTC) at the time the geographic coordinates of the vessel location were determined.

4. The data on the vessel's location specified in clause 3 of these Rules shall be transmitted at least once every 2 hours from the start of the transmission of the data on the vessel's location to the relevant center until the vessel enters the waters of the port of destination.

5. The data on the location of vessels to be transferred to border authorities in accordance with paragraph 3 of these Rules shall be generated by the centers on the basis of data received automatically from vessels equipped, in accordance with the requirements for equipping vessels, with technical means of control that ensure continuous automatic uncorrected transmission of information on the location of the vessel, and other technical means of monitoring the location of the vessel.

The transfer of data on the location of the vessel to the relevant center shall be carried out at least once every 2 hours from the moment of checking the serviceability of the technical means of monitoring the location of the vessel, which is carried out no later than 4 hours before the expected time of the vessel departure from the port and before the vessel enters the waters of the port of destination.

6. The border authority in whose area of responsibility the port (marine terminal) is located (contact details of the border authorities are posted on the website ps.fsb.ru in the information and telecommunications network "Internet"), notifies the captain of the vessel by telephone about the receipt, in accordance with paragraph 2 of these Rules, of data on the location of a specific vessel no later than one hour before the expected time of the vessel departure from the port.

The vessel shall not leave the port until the vessel captain receives the specified message.

7. If the relevant center does not receive the vessel location data in the prescribed manner within 2 hours from the moment the last location data was received, this center shall send a message by e-mail to the shipowner about the termination of receiving the vessel location data. The shipowner shall ensure the transmission from the vessel of the information specified in paragraph 9 of these Rules within 6 hours from the moment of receipt of the said message.

8. If a vessel detects that the transmission of data on the vessel location has ceased while the vessel is at sea, the vessel captain shall ensure that the information specified in paragraph 9 of these Rules is transmitted from the vessel.

9. In the cases specified in paragraphs 7 and 8 of these Rules, the following information shall be transmitted by radio, fax or e-mail to the border authority in whose area of responsibility the port from which the vessel departed on its voyage or the port of destination is located, as well as to the relevant centre:

- a) the name of the vessel, its call sign and the identification number of the International Maritime Organization (if any);
- b) the maritime mobile service identifier MMSI (if any);
- c) the state under whose flag the vessel is navigating;
- d) the geographic coordinates of the vessel location at the time the break of transmission of data on the vessel's location was detected;
- d) date and universal coordinated time (UTC) at the time of detection of the cessation of transmission of data on the vessel position;
- e) port of registration of the vessel;
- g) brief description of the vessel route;
- h) course and speed of the vessel at the time of detection of the cessation of transmission of data on the vessel position;
- i) reasons, date and time of the vessel stoppage (if the vessel is not moving at the time of transmission of information);
- k) reasons for the cessation of transmission of data on the vessel position (if known);
- k) planned time of resumption of transmission of data on the vessel position using technical means of monitoring the vessel position (if known).

10. After transmission of the information stipulated by paragraph 9 of these Rules, every 2 hours by radio communication the border authority in whose area of responsibility the port from which the vessel departed on the voyage or the port of destination is located shall transmit the information stipulated by subparagraphs "a" - "c", "e" and "i" of paragraph 9 of these Rules, as well as the geographic coordinates, course and speed of the vessel at the time of transmission of data on the vessel position.

11. For the transmission of information provided for in paragraphs 9 and 10 of these Rules, Russian shall be used from Russian vessels, and Russian or English from foreign vessels.
